



Form RP1F NOTICE OF TERMINATION (VACANT POSSESSION REQUIRED FOR WORKS)

Residential Parks (Long-stay Tenants) Act 2006 Section 41B

Purpose of this notice

A park operator / managing real estate agent may issue this notice -

- because the park operator is required to carry out works, and vacant possession of the site under the long-stay agreement, or part of the site, is required in order to complete the works; and
- if the tenant has been given evidence showing the basis upon which the works will be carried out.

This notice can require vacant possession of the agreed premises before the last day of a period of a periodic tenancy.

This notice cannot require vacant possession of the agreed premises before the end of a fixed term tenancy.
